Assess your current financial solution and capital needs

Evaluate different types of funding sources (equity, debt, etc.)	
Create detailed financial projections for 3-5 years	
Establish a realistic valuation for your company	
Ensure compliance with legal and regulatory requirements

Negotiation and Closing

Review and negotiate term sheets	
Engage legal counsel to review investment agreements	
Agree on the final valuation and terms	
Finalize and sign the investment agreement	
Create a one-pager or executive summary for quick distribution	

Post-Funding Activities

Description	X
Notify all stakeholders of the successful raise	
Allocate the raised funds according to the plan	
Update the company's cap table	
Maintain communication with investors with regular updates	
Prepare for future funding rounds as needed
